Majority of District Attorneys Endorse “Law Enforcement’s Choice for the Court” – Judge Mike Gableman

First Sheriffs and now DAs; Frontline prosecutors and law enforcement back Judge Gableman

[Burnett County, Wisc....] A bipartisan majority of Wisconsin District Attorneys have endorsed Judge Mike Gableman for the Supreme Court, as his campaign today announced the endorsements of six additional district attorneys.
